**INITIATION OF ONLINE REGISTRATION FOR ADMISSION
IN ARMY PUBLIC SCHOOLS**

1. Kindly refer to IHQ of MoD Letter No B/44607/AG/School/CW-3/Edn dt 13 Mar 2018 addsd to All HQ Comds (Copy Attached).
2. It has been decided to migrate to online registration for admission for the school admissions from this year. To this end a url has been created (<https://www.apsdigicamp.com/admission-registration>). All school Principals are requested to upload this portal on their website and put up a notice at prominent places/notice board of the School to sensitize the parents to register their requirement for admission on it. The link will also be available on AWES website. School Principals are requested to assist the parents in filing up the data on the portal in case they have not registered their admission request on the online portal.
3. The url link will offer a simple form to user which will require certain basic data to be filled to generate a unique ID No. This unique ID No shall be mandatory for the admission. This ID No shall be required as and when the physical application process is being completed by the School authorities.
4. This process is NOT aimed to obviate the requirement of obtaining prospectus, filling forms and other formalities for admission as required by the SOPs of respective schools. The online registration process will prove to be a useful value addition for both the parents and schools. The admission process may be further streamlined in a manner without having a need for long queues of aspiring parents. The school management may retrieve relevant data to manage dis-satisfied parents with transparency.



ADVISORY : ONLINE ADMISSIONS IN ARMY PUBLIC SCHOOLS

1. HQ AWES has mooted a proposal that all Army Public Schools migrate to "online system of regn & admissions".
2. The proposal has been analysed & it is considered that an online sys for regn/admissions to the schools will streamline the procedure, minimize complaints in this regard & enhance transparency. To achieve this, a link has been devp which will be loaded on to the school websites. Alternatively, a parent/student can register for admission on the URL by typing <https://www.apsdigicamp.com/admission-registration> which shall generate a unique ID. This ID shall be required as and when the formal application process is being completed by the School authorities. As all APSs already have their websites & are gradually migrating to digicampus for uniformity under the aegis of AWES, there is no addl fin implication associated with the proposal.
3. In view of the above it is recommended that online regn/admission procedure in APSs be implemented & confirmation/representation in this regard, if any, may please be conveyed at the earliest.

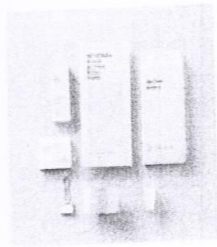
